1. Target MCU

This sample program is created targetting at the TLCS-870/X series.

When using an MCU other than the TLCS-870/X series, refer to the data sheet for that MCU.

2. Overview

This sample program provides a time-of-day (TOD) clock function using TBT interrupts.

3. Description

The program creates a TOD clock using a time-base timer.

It uses the low-frequency oscillation (32.768 kHz) as the source clock and TBT interrupts at fs/2¹³ (250 ms), which are available even in SLOW mode.

4. Passing Data

Set data in the following RAM areas (contiguous addresses):
