### **Terms and Condition for Use of the Software**

#### **1. License**

- 1.1 You may, without any charge to you, use and copy the Program on your facilities, solely for the purpose of developing code for your software which operates on your hardware product(s) containing the LSI manufactured and/or provided by NEC or NEC’s subsidiaries, and distribute the Program with such hardware product(s). Furthermore, you may, without any charge to you, use and copy the Documentation to the extent reasonably necessary to exercise the license granted under this paragraph 1.1 with respect to the Program.
- 1.2 You may have delegate to your subcontractors any portion of the work with respect to the rights granted under paragraph 1.1 above, provided that you shall impose on such subcontractors the obligations contained in these terms and conditions (including, without limitations, the confidentiality obligations) and be responsible for the subcontractors’ compliance with such obligations.
- 1.3 You hereby acknowledge and agree that NEC may modify, alter or change the Software at any time during these terms and conditions without your consent.

#### **2. Period**

- 2.1 NEC may terminate the license granted to you hereunder at any time if you fail to comply with any terms and conditions.
- 2.2 Upon termination of the license, you must destroy or dispose of the Software and any copies thereof.

#### **3. Copyright**

No title and other intellectual property rights to the Software shall be transfer to you, and except as expressly set forth in these terms and conditions, no rights or licenses shall be granted to you in connection with the Software.

#### **4. Restrictions**

- 4.1 You shall not reverse engineer, reverse compile, disassemble or otherwise analyze the Software.
- 4.2 You shall not delete or modify the copyright notice contained on or within the Software.
- 4.3 You shall not convert, change, modify, combine or otherwise change or dispose of the Software, except as expressly granted in these terms and conditions.
